The Bureau provides a means to promote your availability for discussions and presentations about wound prevention and care and associated topics (e.g. reimbursement issues, regulatory guidelines, etc.).

A list of Bureau Speakers is available on the Speakers Bureau page of the AAWC website. The information is promoted regularly so that Members have a chance to be recognized as potential speakers in various subject areas by various sources, including: National and global conferences, seminar coordinators, inservice planners, regional meetings, corporate meeting organizers, career fairs, inspirational event directors, and media sources.

How does it work? AAWC's staff initiates the introduction between speaker and client, based on the client's request to the AAWC for a specific speaker (which will be based upon the speaker's noted area of expertise/interest.) Thereafter, the speaker will decide whether they wish to accept the invitation from a potential client. All further arrangements are made only between client and speaker. The Bureau's policy is not to collect a speaker's fee. However, Bureau speakers may accept any honoraria and expense reimbursement offered by or negotiated with the client. AAWC and its Speakers Bureau do not guarantee utilization of any speaker on its Bureau, nor does it guarantee any specific number of presentations.

  - A list of preferred wound treatment topics for presentation (please try to limit to 40 words and provide in Microsoft Word format)
